5. It is agreed and understood by applicants that this document becomes a contract between an applicant and the Ship Bottom Irish Festival, Inc. when countersigned by an authorized agent of the Ship Bottom Irish Festival Inc.

6. Alcoholic beverages' may not be sold or distributed as per State Law. Vendors who disregard the law, will be closed down and not receive a refund. Rights reserved by Ship Bottom Irish Festival to refuse space which it deems a detraction from the dignity of the festival. All vendors must be in compliance with State and local laws.

**7. ELECTRICITY AND WATER WILL NOT BE PROVIDED, VENDORS TO PROVIDE OWN TABLES AND CHAIRS.**

8. Displays are to be arranged so as not to hide adjoining booths. All tables must be covered with coverings to the floor.

9. Vendors must assume responsibility for the safety of their merchandise and displays against loss or damage by fire, theft, accident or any destructive cause while on the property.

10. Vendors will accept locations as assigned and will only use display racks for self-supporting boards or structures that fit in their assigned area. Nothing is to be placed in the aisles.

11. Storage of all extra merchandise, cartons and containers must be out of sight. We are expecting all vendors to present their wares in a professional manner with business name clearly displayed. An attractive display a reason a festival patron will shop at your booth.

12. Vendors must be set up prior to 9:00am the day of the festival and may not break down prior to close of the event or 7:00pm. *Saturday evening opening is at vendors discretion.*

**13. Each vendor must provide a representative to be on hand for the sale of their merchandise and hereby releases the A. O. H. Div. 4 and/or the Ship Bottom Irish Festival, Inc. from any responsibility for the loss or damage of vendor materials. Vendor agrees to be responsible for all monies handled at their location.**
